NOTICE FOR REGISTRATION OF WORK ASSESSMENTS COINTER PDV 2020 SCIENTIFIC AND MEDIATORS OF EXPERIENCE REPORTS

THE INSTITUTO INTERNACIONAL DESPERTANDO VOCAÇÕES - IIDV, through the Organizing Committee of the VII International Congress of Undergraduate Courses - COINTER PDVL, V - International Congress of Agricultural Sciences - COINTER PDVAgro and IV International Congress of Management and Technologies - COINTER PDVGT and II International Congress of Science Sciences Health - COINTER PDVS that will be held online presents the present call to the academic community.

1. OBJECTIVE:

Select evaluators of scientific works, Ad hoc, in COINTER's, both for the selection stage and for the presentations in Oral Communication and Experience Reports.

2. REGISTRATION:

- **2.1** The registration will be done through the ONLINE FORM, available at: https://bit.ly/formularioparaavaliadores
- **2.2** The registration period will be from July 4th to October 30th, 2020;
- **2.3** In the online form, the candidate may choose to be an evaluator of written works, online presentations, or mediator of cultural circles.

3. REQUIREMENTS:

- **3.1** To be registered in the Congress.
- **3.2** The evaluator must present the minimum condition of the master's student, duly proven;
- **3.3** The training of appraisers must be in accordance with the area chosen for the evaluation of the works:
- **3.4** As the assessment will be on-line, both in written works and for presentations, it is necessary that the evaluator has a notebook, tablet or computer (desktop) with broadband internet access;

4. RESPONSIBILITIES OF THE SELECTED EVALUATOR:

- **4.1** Evaluate, on average, 10 written works, through an online evaluation system, and must send the referee's comment;
- **4.2** Evaluate, works presented online, on average 10 works of oral communication and / or experience report;
- **4.3**. The criteria for evaluating the works are described on the websites of the Congresses in the area regarding the Rules for Submission of Works;
- **4.4** Participate in the online meeting of guidelines on the evaluation process;
- **4.5** Follow the guidelines of the Scientific Committee;



- 5.REGISTRATION: Registration will be open from July 4th to October 30th, 2020.
- 5.1 The registration of the candidate implies knowledge and express acceptance of the rules and conditions established in this call;
- 5.2 Applications after the date established above will not be accepted, except under the interest and need of the Scientific Committee;

6. DOCUMENTS FOR SELECTION

- 6.1 RG / CNH / or Passport;
- 6.2 Proof of Degree (postgraduate certificate of completion, diploma or declaration of enrollment in a strictu sensu postgraduate course).
- 6.3 Filling out the form. (Form described in item 2.1)

7. CANCELLATION OF REGISTRATION:

- 7.1 Entries with incomplete filling in the "Registration Form" or that are not in accordance with the rules of this notice will be denied;
- 7.2 Candidates who provide untrue information or who do not send the necessary documents to prove the category informed will be disqualified;
- 7.3 If the Scientific Committee examines and proves the falsity of any information, at any time, the candidate will be immediately excluded from the process and may be legally liable for any losses.

8. CRITERIA FOR PARTICIPATION IN THE REGISTRATION OF EVALUATORS AND MEDIATORS

- 8.1 Attend an orientation meeting (Online).
- 8.2 Complies with item 3 of this call.
